DURING THE FISCAL YEAR 2021-2022, WE AFFORDED 21,232 LBS OF LOCALLY GROWN, FRESH PRODUCE TO FOLKS. 25% OF THE REVENUE WE GENERATED THIS SEASON ON THE MARKET CAME FROM PUBLIC BENEFIT ASSISTANCE DOLLARS, SPECIFICALLY FARMERS' MARKET NUTRITION PROGRAM CHECKS FROM SENIORS AND MOTHERS WITH INFANT CHILDREN.

THE FARM STAND IS ANOTHER POINT OF ACCESS TO HEALTHY FOODS. THE FARM STAND OPERATES ONE FRIDAY A MONTH AND DISTRIBUTES AN AVERAGE OF 4,000 LBS OF FRUITS AND VEGETABLES TO AROUND 250 PEOPLE AT A TIME. IN FISCAL YEAR 2021-2022, THE FARM STAND DISTRIBUTED 48,408 LBS OF PRODUCE TO 3,000 PEOPLE WITH THE HELP OF OVER 205 VOLUNTEERS
